

## **Terms and Conditions for Member-Get-Member Programme**

## When can you enjoy this offer

1. The promotional period for the Member-Get-Member Programme ("MGM Programme") is from 01 February 2023 until terminated or withdrawn by Elephant Please Limited ("Elephant Please").

### What is the offer

2. During the promotional period, if the Referee achieves the respective requirements, within one-hundred-and-eighty (180) days after the Referee has successfully opened an Elephant Please account, the Referrer and Referee can receive the respective rewards:
